- The Limited Partners shall not be called upon to make any further cash contributions and shall not be liable for any further The liability of each of the Limited Partners for contributions. the losses of the partnership shall in no event exceed the contribution of the partner to the capital of the partnership. Bert Wall will, as an additional contribution, render accounting services to the Limited Partnership and it is agreed that in addition to his pro rata interest in the partnership by virtue of his cash contribution the services contributed by him will offset the value of an additional two and one-half percent (2-1/2%) ownership interest, which is by this agreement vested in him in contemplation of the services he will render, and Gary Edin's contribution will be in the form of offsetting the value of his development and promotional services performed in the interest of this Partnership in return for a twelve and one-half percent (12-1/2%) ownership interest.
- The net profits of the Partnership shall be divided among the partners in the percentages set forth opposite their respective names:
