EASEMENT

THIS INDENTURE made and entered into in Douglas County, Nevada this // day of July, 1972, by and between FREDERICK W. DRESSLER, LOUIS W. BERGEVIN, and LUETTA BERGEVIN, his wife, parties of the First Part, and the GARDNERVILLE RANCHOS GENERAL IMPROVEMENT DISTRICT, Second Party,

WITNESSETH:

That for and in consideration of the sum of TEN (\$10.00) DOLLARS, cash in hand paid, the receipt of which is hereby ackknowledged, parties of the First Part have this day bargained and sold, and by these presents do bargain, sell, convey, transfer, and deliver unto Second Party, a permanent easement and right of way, including the perpetual right to enter upon the real estate hereinafter described, at any time that it may see fit, and construct, maintain, and repair underground pipelines and/or mains for the purpose of conveying sewage over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of said pipelines and/or mains, and the further right to remove trees, bushes, undergrowth, and other obstructions interfering with the location, construction, and maintenance of said pipelines and/or mains, and also to build, construct and maintain other type of public utilities.

The land affected by the grant of this easement and right of way is located in the County of Douglas, and State of Nevada, and is more particularly described as follows:

A ten foot wide easement for sewer line construction access and maintenance and public utilities lying wholly within the southwest quarter of Section 16, Tl2N, R20E, M.D.B. & M. and being further described as follows:

An easement, 10 feet in width, beginning at the 1/4 corner common to Sec. 16 and Sec. 17 and extending southerly along the section line a distance of 661.85' and being further described

as lying easterly from; adjacent to; and parallel with said section line.

Said easement to extend southward to the Bing property and connect with the sewer easement acquired by grantee from D GERALD BING (see attached map).

The easement and right of way hereby granted covers a strip of land 10 feet in width over and across the above described and.
