For the Purpose of Securing: 1. Performance of each agreement of Trustor Incorporated by reference or contained herein. 2. Pay ment of the indebtedness evidenced by one promissory note of even date herewith, and any extension or renewal thereof, in the princi
pal sum of \$5,000.400 executed by Trustor in favor of Beneficiary or order. 3. Payment of such additional sums as may hereafter be advanced for the account of Trustor or Assigns by Beneficiary with interest thereon.
Trustor grants to Beneficiary the right to record notice that this deed of trust is security for additional amounts and obligations not specifically mentioned herein but which constitute indebtedness or obligations of the Trustor for which Beneficiary may claim this deed of trust as security.

NINTH: It is expressly agreed that the trusts created hereby are irrevocable by the Trustor.
