

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 28th day of October, 1977, between JEFFREY A. LINCOLN and JENNIFER C. LINCOLN, husband and wife, herein called TRUSTOR, whose address is _____ (number and address) _____ (city) _____ (state) _____ (zip) and

DOUGLAS COUNTY TITLE CO., INC., a Nevada corporation, herein called TRUSTEE, and LOIS G. LOHREY, an unmarried woman, herein called BENEFICIARY,

WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, that property in DOUGLAS County, Nevada, described as:

A portion of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section 26, Township 13 North, Range 18 East, M.D.B.&M., more particularly described by metes and bounds as follows:

Commencing at the quarter corner common to Sections 23 and 26, Township 13 North, Range 18 East, M.D.B.&M., thence Westerly along the Section line between said Section 23 and 26 a distance of 900.50 feet to the true point of beginning; thence South 0°08' West a distance of 138.56 feet; thence North 89° 46' West a distance of 82.30 feet; thence North 0° .08' East a distance of 138.56 feet; thence South 89°46' East a distance of 82.30 feet to the true point of beginning.

Assessor's Parcel No. 07-180-06.

The note secured by this deed of trust contains a prepayment recital. **This Deed of Trust is subordinate and subject to that Subordination Agreement executed by the Trustor and Beneficiary of even date.**

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the sum of \$ _____ with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada on January 30, 1968, in the book and at the page thereof, or under the document or file number, noted below opposite the name of such county, namely:

The undersigned Trustor requests that a copy of any notice of default and any notice of sale hereunder be mailed to him at his address hereinbefore set forth.

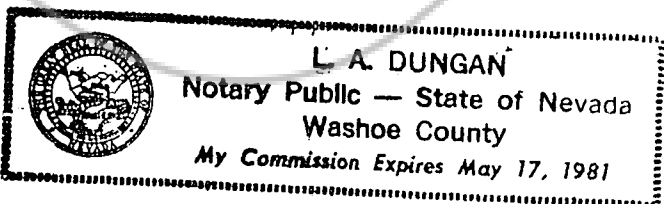
