

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 24th day of October, 1977, between JEFFREY A. LINCOLN and JENNIFER C. LINCOLN, husband and wife, herein called TRUSTOR, whose address is c/o Link Realty Post Office Box 4988 Stateline, NV 89449 and DOUGLAS COUNTY TITLE CO., INC., a Nevada corporation, herein called TRUSTEE, and JAMES A. PAULSON and CAROLYN B. PAULSON, husband and wife, herein called BENEFICIARY,

WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, that property in the unincorporated area, Douglas County, Nevada, described as: A portion of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section 26, Township 13 North, Range 18 East, M.D.B.&M., mor particularly d escribed by metes and bounds as follows:

PARCEL 2: BEGINNING at a point on the section line between Sections 23 and 26, Township 13 North, Range 18 East, M.D.B.&M., which is West 819.00 feet from the quarter corner between Section 23 and 26, thence South 0 08' East 263.54 feet; thence North 89 46' West 81.50 feet; thence North 0 08' East 263.54 feet; thence North 89 46' East 81.50 feet to the point of beginning, containing one-half acres, mor or less, all situate in the NE 1/4 of the NW 1/4 of Section 26, Township 13 North, Range 18 East, M.D.B.&M. A.P. #7-180-08

BENEFICIARY HEREBY AGREES TO SUBORDINATE HIS LIEN, EVIDENCED BY A PROMISSORY NOTE HEREIN SECURED TO A FIRST DEED OF TRUST IN FAVOR OF A RECOGNIZED LENDING COMPANY FOR PURPOSES OF A CONSTRUCTION LOAN NOT EXCEED \$125,000.00 FOR IMPROVEMENTS TO ERECTED ON THE HEREIN DESCRIBED PROPERTY.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the sum of \$ 35,000.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada on January 30, 1968, in the book and at the page thereof, or under the document or file number, noted below opposite the name of such county, namely:

The Beneficiary or the collection agent appointed by him may charge a fee of not to exceed \$15.00 for each change in parties, or for each change in a party making or receiving a payment secured hereby.

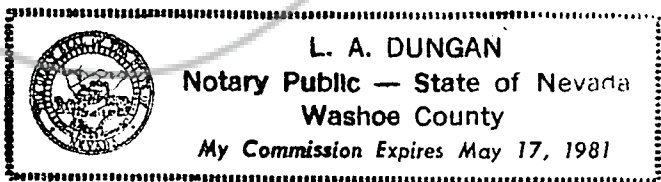
