INDENTURE

UNINCORPORATED TRUST CONTRACT

THIS TRUST ORGANIZATION SHALL BE OF THE TYPE KNOWN AS A COMMON LAW TRUST AND IS TO BE ADMINISTERED BY LEGAL PERSONS HOLDING TITLE AS JOINT TENANTS IN FEE SIMPLE AND NOT AS TENANTS IN COMMON, TO COL-LECTIVELY ACT AS A BOARD OF TRUSTEES, ACTING UNDER A LIFE PURPOSE AND A RELIGIOUS BELIEF AS HEREIN SET FORTH, AND ACCORDING TO THE INALIENABLE COMMON LAW RIGHTS AFFORDED MAN.

DECLARATION OF AUTHORITY

This instrument shall serve as the Trustees' sufficient guide, supplemented from time to time by their resolutions covering contingencies as they arise and are recorded in the Minutes of their Trust Minutes are a portion of the by-laws, rules and regulations of this Trust; said Minutes to be ratified always by a majority of the Trustees then in office. The Trustees' Regulations, however, as the original by-laws of this Trust, may be changed only by unanimous accord of the Board of Trustees wherein not precluded by an express prohibition against change. Only such authority as awarded herein is possessed by the Trustees, Officers, Agents or Employees of this Trust, thus intending only to leave open for the court, should occasion arise, the question of the conscientious dealing of those persons.

The Trustees shall have all the powers necessary, convenient or appropriate to effectuate the purposes of the Trust, and may take any action which they deem necessary or desirable and proper to carry out such purposes. Any determination of the purposes of the Trust made by the Trustees in good faith shall be conclusive. construing the provisions of this Trust Indenture Declaration, the Trustees' Regulations and the Trust Minutes, the presumption shall be in favor of the grant of powers to the Trustees.

ACCEPTORS hereof as joint tenants in fee simple and not as tenants in common as Trustees who collectively shall compose the Board of Trustees for the purpose of conducting the business of THIS TRUST. The Trustor hereby appoints and constitutes the above designated Trustees, to be in fact, Trustees and Board of Trustees of the Pure Trust Organization hereby created and established.

CORPUS AND INITIAL DIRECTION

For and in consideration of the objects and purposes set forth herein and other full and adequate considerations of value, the receipt of which is hereby acknowledged, the Trustor hereby agrees that certain properties, projects, equities, formulae, entities, patents, copyrights, royalties, trademarks, goodwill and other business interests shall be assigned, conveyed and delivered unto said Board of Trustees, in Trust Irrevocable, who shall act as absolute owners and hold title as joint tenants in fee simple, and not as tenants in common, to collectively act by virtue of this covenant as a Board of Trustees under the name herein designated for and in behalf of the Trust Certificate Holders under the conditions specified in this Trust Organization Indenture, the Trustees' Regulations and the Trust Minutes. The Trust Name and other things of value shall constitute a Trust (Estate) including rights in reversion or remainder wherever situate.

The first Board of Trustees may increase or decrease the number of Trustees as deemed appropriate to the affairs of the Trust Organization.

DECLARATION OF PURPOSE

The named Board of Trustees, for themselves and their successors In Trust Irrevocable, do accept this Declaration of Trust and do thereby agree to accept the properties conveyed and acknowledge acceptance of and delivery of all of the properties specified, together with all of the terms herein set forth, agreeing to conserve and improve the Trust Organization for the purpose of increase of the Trust Estate, exercising their best judgement and discretion in accordance with this Trust Organization Indenture, the Trustees' Regulations and the Trust Minutes, making distributions of portions of the proceeds and income as in their discretion and according to the minutes should be made, and upon final liquidation distributing the assets to the existing Trust Certificate Holders as their contingent rights may appear; and in all other respects administering said Trust Organization in good faith and in strict conformity hereto.

The terms and conditions of this Trust Organization Indenture shall provide, under a common law right to contract, the pursuit of personal happiness and the maximizing of lifetime efforts and the protection of an estate in order to promote the general welfare and achieve a life purpose and according to any personal moral or religious beliefs, which are all sustained by this Trust Organization.

TO WIT:

Whereas the Life Purpose is to sustain, protect and improve this Trust Organization for the Trust Certificate Holders to possess the things of this life sufficient to provide for growth, health, protection, education, refinement, recreation, welfare, expansion, preservation and continuation, it is believed that to fail to plan for such things will certainly cause failure of the estate purpose. Therefore, it is proposed to use this Trust Organization as a plan for the achievement and improvement of a Life Purpose. This Trust Organization and the Life Purpose is sustained by Moral Belief that man is under a great Universal Spirit to replenish the earth and subdue it and have dominion over every living thing that moveth upon the face of the earth. Thus it is a Moral Belief that all are under a Divine Mandate to establish and care for and provide a Life Estate.


