 advanced for the account of Trustor or Assigns by Beneficiary with interest thereon.

 and with respect to attorneys' fees provided for by covenant 7 the percentage shall be 10 % (Douglas Co.)

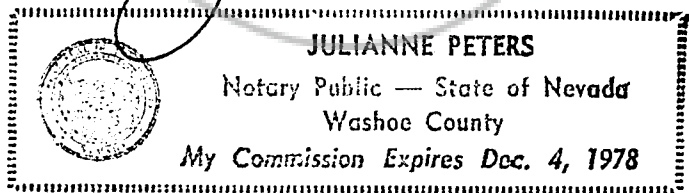
