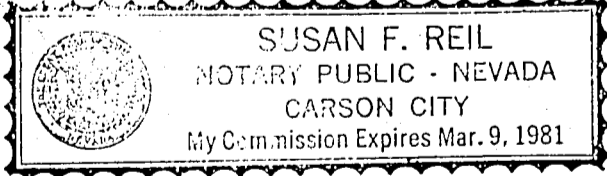
A parcel of land described as:
