

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 30th day of January, 1979, between

 reversion and reversions, remainder and remainders, rents, issues and profits thereof, and also all the estate, right, title and interest, homestead
 or other claim or demand, as well in law as in equity, which the Grantor now has or may hereafter acquire, of, in or to the said premises or any part
 thereof, with the appurtenances.

FOR THE PURPOSE OF SECURING: 1. Performance of each agreement of Grantor incorporated by reference or contained herein. 2. Pay-
 ment of the indebtedness evidenced by one promissory note of even date herewith and any extension or renewal thereof, in the principal sum of
 \$ 15,000.00 executed by Grantor in favor of Beneficiary or order. 3. Payment of such additional sums as may hereafter be ad-
 vanced for the account of Grantor or Assigns by Beneficiary with interest thereon.

TO PROTECT THE SECURITY OF THIS DEED OF TRUST, parties agree that by the execution and delivery of this Deed of Trust and the
 note secured hereby, provisions (1) to (11) inclusive of the Deed of Trust recorded in the Official Records in the office of the county recorder of

 provided by covenant 4 shall be the same rate as in the note secured hereby and counsel fees provided for by covenant 7 shall be a reasonable
 percent. Beneficiary may charge an assumption fee of \$ n/a.

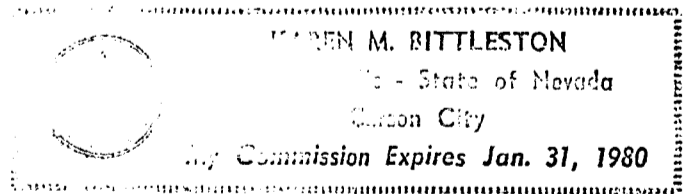
