EXHIBIT "A"

DESCRIPTION

All those certain lots, pieces or parcels of land situate in the County of Douglas, State of Nevada, described as follows:

PARCEL NO. 1:

The Southwest 1/4 of the Southeast 1/4 of Section 15, and the Northwest 1/4 of the Northeast 1/4 of Section 22, all in Township 13 North, Range 19 East, M.D.B.&M., more particularly described as follows:

EXCEPT THEREFROM all that portion of said land lying within the lines of Foothill Road as conveyed to the State of Nevada, in instrument recorded September 29, 1950, in Book Z of Deeds, Page 290, Douglas County, Nevada, records.

EXCEPT THEREFROM all that portion of said land conveyed by EDGAR R. JOHNSON and wife to WALLEY SPRINGS DEVELOPMENT COMPANY, a Nevada corporation, in Deed recorded August 2, 1971, in Book 89, Page 392, Document No. 53734, Official Records of Douglas County, Nevada, and more particularly described as follows:
