

NOTICE OF CLAIM OF LIEN

2 NOTICE IS HEREBY GIVEN that between December 5, 1978
3 and January 13, 1979, ~~XXXX~~, CHAS. C. MEEK LUMBER CO. OF
4 CARSON CITY, the claimant herein, furnished building materials to
5 MARVIN R. FORD, for use in the
6 construction, alteration or repair of a building or structure in
7 DOUGLAS COUNTY, Nevada, all of which was so actually
8 used, and all of which was of the reasonable value of ONE THOUSAND
9 SEVEN HUNDRED TWENTY and 38/100 DOLLARS (\$ 1,720.38), after
10 deducting all just credits and offsets, there is now owing and
11 unpaid to CHAS. C. MEEK LUMBER CO. OF CARSON CITY, claimant herein,
12 from the said MARVIN R. FORD, the full
13 sum of ONE THOUSAND SEVEN HUNDRED TWENTY and ^{38/100} DOLLARS
(\$ 1,720.38),
14 and that the claimant has demanded and does now demand the payment
15 thereof; that all of said material was sold on open account and
16 payment was due on the day of delivery, that said materials con-
17 sisted of miscellaneous building material.

18 The description of the property to be charged with a lien
19 for the payment of this claim is as follows:

22 North Side Railroad, a strip of land 50 feet

27 and less than ninety (90) days have elapsed since the completion
28 of work or improvement.

30 CITY, pursuant to the provisions and laws of the State of Nevada
31 relating to liens of mechanics and others, claims a lien upon the
32 above-described premises, together with the buildings and improve-

3 and for the cost of preparing and filing of this lien.

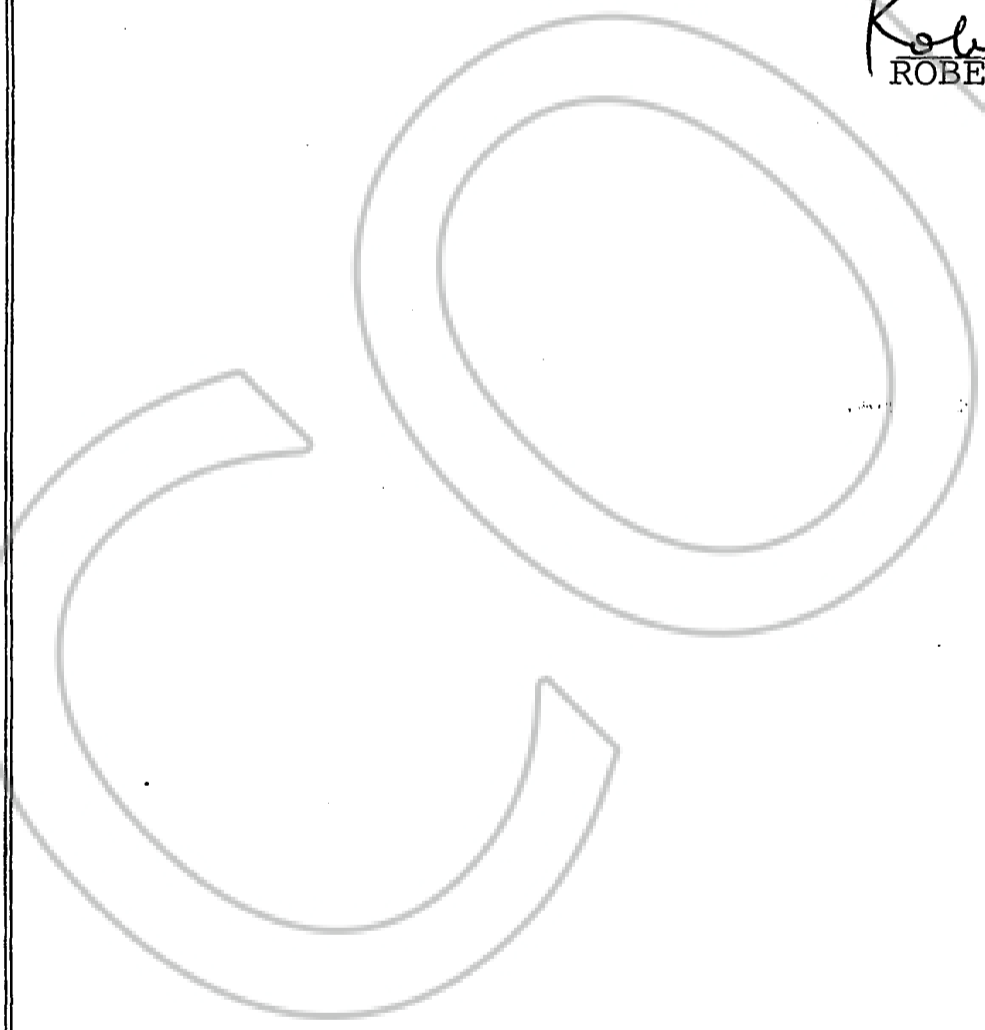
