
## PARTIAL RECONVEYANCE

BEGINNING at the Northeast corner of Parcel 4 of that Record of Survey filed October 10, 1969 in Book 1 of Maps as Decument Ro. 45990 of Official Records, the TRUE POINT OF BEGINNING, further being described as a point on the North line of said Section 18 from which the quarter corner common to Sections 18 and 7 bears South 89°31'00" West 157.31 feet; thence Easterly along said section line North 89°31'00" East 113.90 feet to a point on the Westerly right of way of U.S. Highway 395; thence Southerly along said right of way South 28°50'27" East 700.65 feet to the beginning of a tangent curve to the right having a radius of 9900 feet and a central angle of 00°05'43"; thence along said curve an arc distance of 16.46 feet to the center of a 60 foot wide access and utility casement; thence leaving said curve and right of way Westerly along said access and utility easement centerline South 86°43'00" West 623.04 feet to the Southeast corner of said recorded Parcel 4; thence Northerly along the East boundary of said Parcel 4 North 03°17'00" West 652.32 feet to the point of beginning.

RESERVING THEREFROM a non-exclusive road and utility easement on and over the Southerly 15 feet, together with a non-exclusive road and utility easement on and over a strip of land 15 feet in width lying Southerly of, parallel and contiguous to the Southerly line of the herein described parcel of land.
