4                   THIS DEED MADE THIS 24<sup>th</sup> day of April, 1980,  
5                   between Daniel J. Monen, Jr., Party of the First Part, hereinafter  
6                   called GRANTOR, and the COUNTY OF DOUGLAS, a political subdivi-  
7                   sion of the STATE OF NEVADA, Party of the Second Part, herein-  
8                   after called GRANTEE,

9                   WITNESSETH:

10                  THAT THE GRANTOR, for an in consideration of the sum of ONE  
11                  DOLLAR (\$1.00), lawful money of the United States of America, the  
12                  receipt whereof is hereby acknowledged, does by these presents,  
13                  Grant, Bargain, and Sell unto the Grantee and to its assigns for-  
14                  ever, a perpetual drainage easement for the location, construction,  
15                  and maintenance of a drainage facility and necessary incidents  
16                  thereto, upon, over, across, and through all that real property  
17                  situate in the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 9, T.13N., R.18E.,  
18                  M.D.B.& M., County of Douglas, State of Nevada, and more parti-  
19                  cularly described as follows:

20                  A fifteen foot floating easement over that certain tract  
21                  of land as defined in Book 1173, page 1053, Document 70411,  
22                  Official Records of Douglas County, said easement to follow  
23                  the northeastern edge of the existing graded road that con-  
24                  nects South Martin Drive (Zephyr Heights Subdivision re-  
25                  cord plat) with North Martin Drive (as paved and improved  
26                  by the County of Douglas in accordance with the plans ap-  
27                  proved by the Board of County Commissioners of Douglas  
28                  County, Nevada on November 4, 1966.) See attached Exhibit "A"




