


That, under and by virtue of the provisions of the Nevada Revised Statutes, Chapter 361.585, I, Yvonne Bernard, as Treasurer and Tax Receiver of said County of Douglas, State of Nevada, execute this tax certificate authorizing the County Treasurer, as trustee for State and County, to hold the property described herein for a period of two years after the date hereof. The property, which is herein-after described, is held subject to redemption within two years from the date hereof, by payment of said taxes and accruing taxes, penalties, and cost, together with interest at the rate of ten per cent per annum from date until paid as provided by law, such redemptions made in accordance with the provisions of the Civil Practice Act of the State in regard to real property sold under execution.

Following is a list of taxpayers, known or unknown, a description of the property held under this certificate and the amount of delinquent taxes, delinquencies, and the cost of advertising chargeable against each for the year 1978-1979.
