have elapsed since the completion of work or improvement.

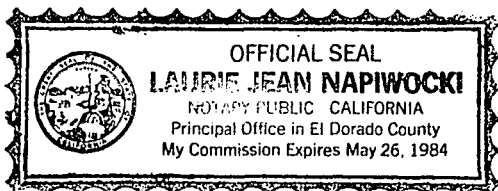
