There is now owing and unpaid upon said note the sum of \$ 95,923.59 principal, and interest thereon from May 22, 1980.

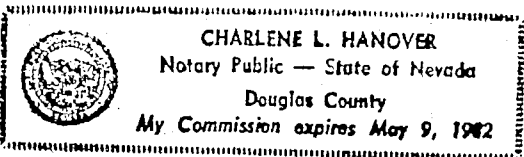
