

1                   ASSIGNMENT OF INTEREST UNDER  
2                   SECOND DEED OF TRUST AS COLLATERAL SECURITY

3                   Ra Construction Corporation, a Nevada Corporation, and  
4 Raymond M. Smith, Inc., a Nevada Corporation, herein referred to  
5 as ASSIGNOR, hereby assigns to LINK REALTY, INC., a Nevada Corpor-  
6 ation, herein referred to as ASSIGNEE, as collateral security for  
7 the payment of ONE THOUSAND EIGHTY SEVEN AND 50/100th DOLLARS  
8 (\$1087.50), that assignor owes assignee as REAL ESTATE BROKERS  
9 COMMISSION, that certain SECOND DEED OF TRUST, dated January 5,  
10 1981, made and executed by GREGORY LEE TEN-BROECK and CHERIE L.  
11 TEN-BROECK, husband and wife as joint tenants, as TRUSTOR, to  
12 ASSIGNOR as BENEFICIARY, recorded on January 6, 1981, in  
13 the office of the Douglas County Recorder of the State of Nevada,  
14 as Document Number 52272, conveying, in trust, the follow-  
15 ing described property:

16                   Lot 7, in Block A, as shown on the Amended Map  
17 of Ranchos Estates filed in the office of the  
18 County Recorder of Douglas County, State of  
Nevada, on October 30, 1972, Document No. 62493.

19                   Together with the Note described in such Deed of Trust,  
20 and the money due and to become due thereon with interest;

21                   But on the express condition that if assignor, their  
22 assigns or legal representatives, shall pay or cause to be paid  
23 to assignee, or its legal representatives, or assigns, the afore-  
24 said sum of ONE THOUSAND EIGHTY SEVEN and 50/100th DOLLARS  
25 (\$1,087.50) on or before October 6 1981, this assignment shall  
26 be void; it being made for the sole purpose of securing the pay-  
27 ment of such sum of ONE THOUSAND EIGHTY SEVEN and 50/100th  
28 DOLLARS (\$1,087.50) as herein specified.

29                   It is agreed that in the event assignee, its assigns or  
30 legal representatives shall collect and receive the money due on  
31 the Note secured by the Deed of Trust hereby assigned, he or they  
32 shall, after retaining the sum of ONE THOUSAND EIGHTY SEVEN and

1 50/100th DOLLARS (\$1,087.50), and his or their reasonable expenses  
2 incurred in so collecting and receiving, pay the surplus, if any,  
3 to assignor, their assigns, or legal representatives.

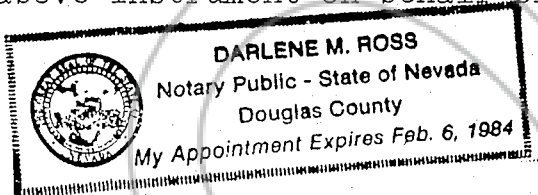
