In consideration of the mutual covenants between the parties, and for good and valuable consideration, comes now the undersigned, JAMES A. HUSSMAN and KATHRYN HUSSMAN, husband and wife, and GEORGE HUSSMAN and MILDRED HUSSMAN, husband and wife, hereinafter referred to only as "Optionors", and MICHAEL GILBERT, a single man, hereinafter referred to only as "Optionee", and hereby modify the original Option for Purchase of Real Estate together with any Agreements for Extension as executed as follows:

A. The said option shall continue on a monthly basis ^{only until May 1, 1981} upon payment to Optionors of the sum of ONE THOUSAND AND NO/100 DOLLARS (\$1,000.00) per month, with said sums including those already paid being applied to the purchase price of the subject real property.

B. The monthly extension shall continue up to and including the 1st day of ^{May} 1981, whereupon the original terms for purchase shall again apply.

In all other respects the original Option for Purchase of Real Estate dated the 9th day of March, 1979, together with the Agreements for Extension of same are reaffirmed.

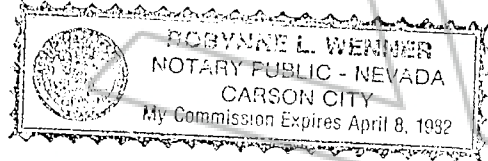

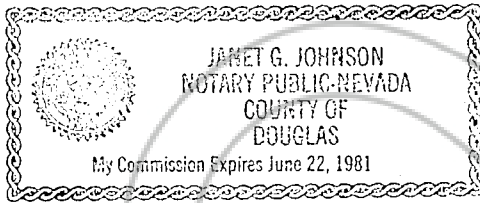

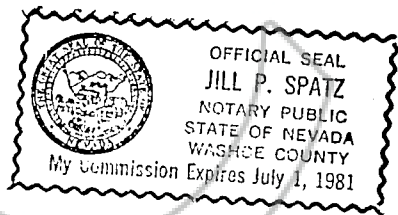
