

AMENDMENT OF

DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

SHADOW RUN, DOUGLAS COUNTY, NEVADA

The undersigned, JOSEPH S. LODATO, CRAIG L. LODATO and DONALD M. THOMPSON, owners of that certain real property situated in the County of Douglas, State of Nevada, particularly described in Exhibit "A" attached hereto and made a part thereof, hereby agree to and do amend the Declaration of Covenants, Conditions and Restrictions affecting said property, recorded May 2, 1978, in Book 578 of Official Records, at Page 133, Douglas County, Nevada, as follows:

- 1. Paragraph 9 of said Declaration is hereby deleted, and in its place is substituted the following paragraph:

"No more than 12 chickens and one pig may be maintained on the property, and no more than two of such animals as dogs or cats will be allowed, and shall not be allowed to run at large or become a nuisance or annoyance to the neighborhood. Other animals, including but not limited to horses, cattle and sheep, shall be limited to one per acre of land." "To a total combined maximum limit of 20 on all of parcel in Exhibit A."

- 2. Paragraph 19 of said Declaration is hereby deleted, and in its place is substituted the following paragraph:

"Lighting by Mercury Vapor Lamp or any lighting on telephone poles will not be allowed. No outdoor lighting may be mounted more than eight feet above ground, except that "security lights", such as are customarily mounted on barns or other outbuildings will be permitted, and which lights are on temporarily while owner is outside and shall be off through the night. In no case shall security light be over 12 feet above ground level."
