

NOTICE OF CLAIM OF LIEN

NOTICE IS HEREBY GIVEN that between November 6, 1980
and February 25, 1981 RIEFF CONSTRUCTION OF ZEPHYR COVE,
NEVADA, the claimant herein, furnished bulding materials to
Cargo Properties, Inc. for use in the construction,

together with the costs of preparing, filing and serving this lien.

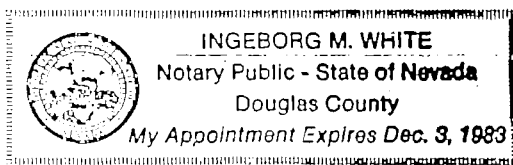

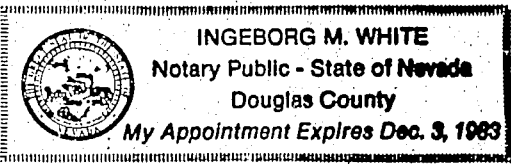
