16 publication of notice of sale by payment to the County Treasurer  
17 of an amount equal to the taxes accrued, together with any costs,  
18 penalties and interest legally chargeable against such property,

20 WHEREAS, the parties of the second part are not  
21 entitled to have such property reconveyed pursuant to the Nevada  
22 Revised Statutes Section 361.585;

23 NOW, THEREFORE, the said party of the first part,  
24 pursuant to Nevada Revised Statutes and in consideration of the  
25 taxes, costs, penalties and interest paid by the party of the  
26 second part, the same being in legal effect made, does by these  
27 presents, reverse, release, quitclaim and convey unto the parties  
28 of the second part and to their successors, all right, title and  
29 interest to the properties described in Exhibit "A", situate in  
30 the County of Douglas, State of Nevada.

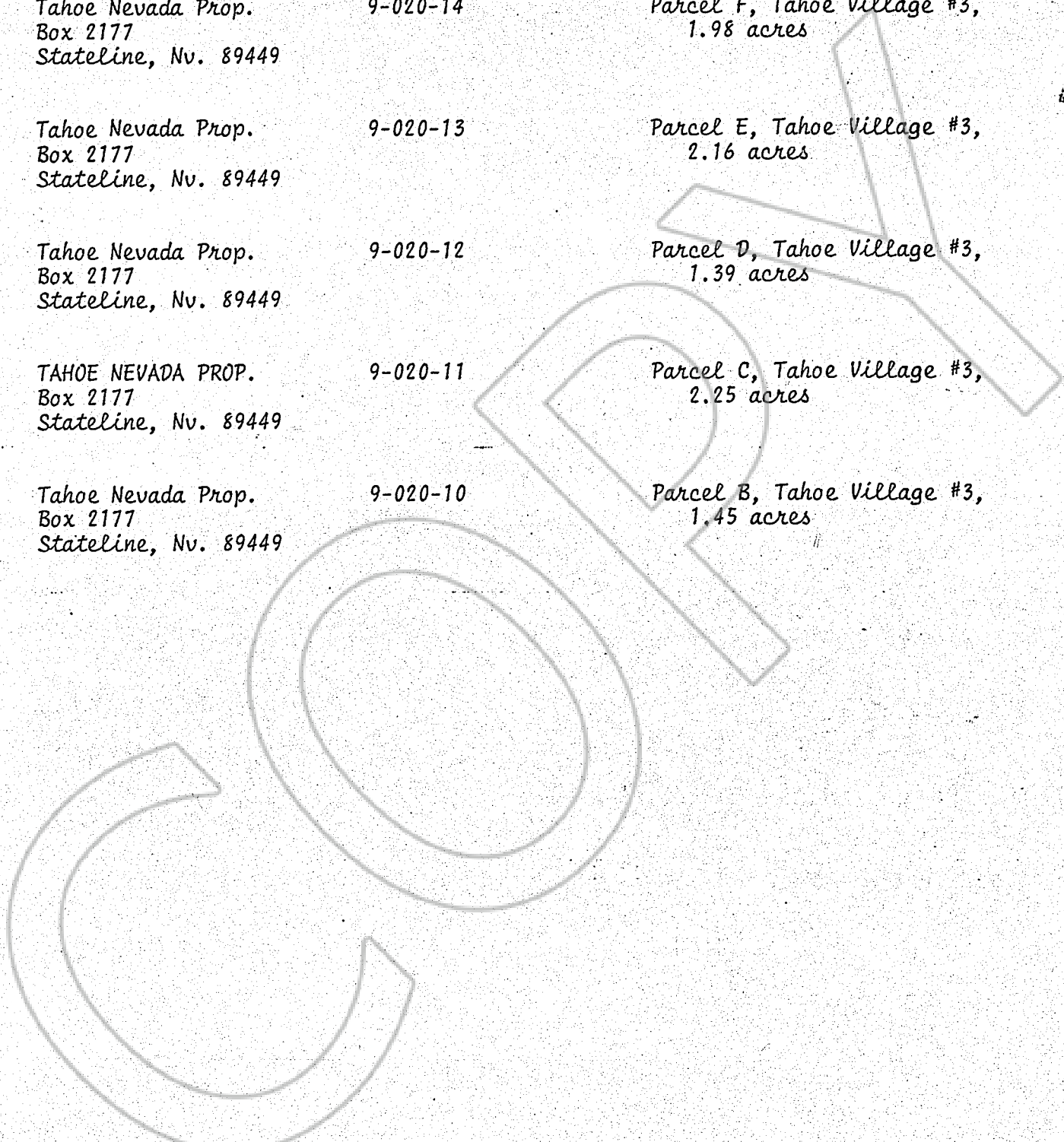
1 anywise appertaining to the reversion, remainders, rents, issues
