13 WILLIAM G. GODECKE, as executor of the Will of FRIEDA
14 GODECKE, deceased, having filed his petition for settlement
15 and for final distribution, and the petition coming on this
16 31st day of March, 1981, regularly for hearing, the
17 court finds.

18 Notice of the hearing of the petition has been regularly
19 given as prescribed by law.

20 All acts and transactions of the executor of the Will of
21 FRIEDA GODECKE, deceased, during the period of its administration
22 are truly shown and should be approved, and all allegations of
23 the petition for its settlement and for final distribution are
24 true.

25 FRIEDA GODECKE died testate on October 16, 1980 in the
26 city and County of Carson, State of Nevada, and was at the time
27 of her death a resident of Douglas County, Nevada.

28 On November 25, 1980, WILLIAM G. GODECKE was appointed as
29 executor of the decedent's Will and qualified as such on the
30 same day and since then has been and now is the executor of the
31 decedent's Will.

1 Notice to creditors has been given as required by law, the
2 time for filing or presenting claims has expired, and the estate
3 is now in a condition to be closed.

4 All claims filed or presented against the estate have been
5 allowed by the executor, are approved by the court, and have
6 been paid.

7 That the executor has waived his right to any fee and a
8 waiver is on file.

9 That the residuary beneficiaries of the estate have waived
10 a formal accounting and a waiver is on file. All named legatees
11 of the decedent's Will have received their legacy in accordance
12 with the list left by the decedent and receipts have been filed
13 herein.

14 That the executor and his attorney have agreed said attorney
15 should receive a fee in the sum of \$1100 for services rendered
16 in the administration of this estate and that this sum is
17 reasonable.

18 Distribution should be ordered as prayed for in the petition.
19

20 IT IS ORDERED AND ADJUDGED that:

21 1. The administration of the estate is brought to a close;
22 2. That the notice to creditors has been given as required
23 by law;

24 3. All acts and transactions of the executor relating to
25 the matters set forth in the petition for distribution are
26 confirmed and approved;

27 4. The executor has waived his right to compensation for
28 services rendered in the administration of this estate;

29 5. Said executor should pay his attorney, JOHN P. DAVIS,
30 the reasonable sum of \$1100 for services rendered in the admini-
31 stration of this estate.

1 6. The legacy of the below described vehicle to JANE MARIE
2 AMERINE is confirmed and approved and distribution is ordered
3 accordingly;

6 7. The residuary estate consisting of cash monies totalling
7 \$ 3298.97 and a 9/56 interest in the below described real
8 property situate in Douglas County, Nevada, be distributed in
9 equal shares to WILLIAM G. GODECKE and STANLEY H. GODECKE:

10 All that portion of the Northwest Quarter of Section 29,
11 Township 13 North, Range 20 East, M.D.B. & M., particularly
described as follows:

12 Beginning at the Southwest corner of the parcel to be
13 described hereby, being a point in the South line of the
14 Northwest Quarter of said Section 29, and from which the
15 South Quarter corner of Section 30, Township 13 North,
16 Range 20 East, M.D.B. & M., bears South 89°54'12" West
17 687.31 feet and South 44°45'27" West, 3764.09 feet; thence
from the point of beginning and along the South line of
said Northwest Quarter South 89°29'26" East 324.29 feet;
thence North 9°04'08" West 183.92 feet; thence North 88°
47'40" West 291.35 feet; thence South 1°14'26" West 184.92
feet to the Point of Beginning.

18 8. Any other property of the estate not known or discovered
19 that may belong to the estate or in which the decedent or the
20 estate may have any interest shall be distributed in equal shares
21 to WILLIAM G. GODECKE and STANLEY H. GODECKE the residuary
22 beneficiaries of the decedent's Will.
