paid so far as the hereinafter described property is affected thereby:

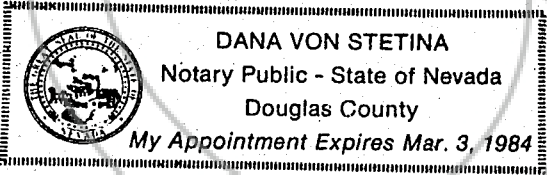
NOW, THEREFORE, SIERRA LAND TITLE CORPORATION, a Nevada corporation,
