TO HAVE AND TO HOLD, the same, without any warranty, unto the person or persons legally entitled thereto, their heirs and assigns forever.

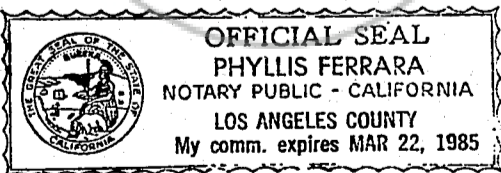
