

DEED OF PARTIAL RECONVEYANCE

1 WHEREAS, a portion of the property secured by Modification of Deed of Trust
2 dated April 27, 1981 and recorded May 1, 1981, as instrument no. 55898
3 in book 581, page 21 of Official Records of Douglas County, State
4 of Nevada, executed by OSTROW and REAGAN, a General Partnership, to TAHOE SAVINGS
5 AND LOAN ASSOCIATION, a California corporation, as beneficiary, has been released.

6 WHEREAS, SOUTH TAHOE INVESTMENT CORPORATION, a Nevada corporation, is
7 Trustee under Deed of Trust dated September 26, 1980, executed by OSTROW and
8 REAGAN, a General Partnership, as Trustor, to secure certain obligations in favor
9 of TAHOE SAVINGS AND LOAN ASSOCIATION, a California corporation, which was

17 payment of additional Promissory Note, executed and delivered on the 28th day
18 of April, 1981 to TAHOE SAVINGS AND LOAN ASSOCIATION, a California corporation;

21 ASSOCIATION, a California corporation, the present record owner and holder of
22 the Note and of the indebtedness secured by said Deed of Trust; SOUTH TAHOE
23 INVESTMENT CORPORATION, a Nevada corporation, as Trustee, hereby grants without
24 warranty, expressed or implied, to the person or persons legally entitled there-

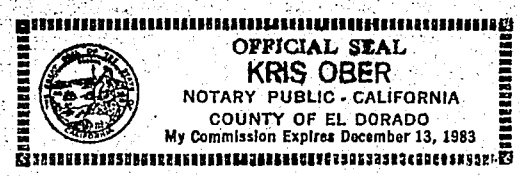
