

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS 22nd May, 1981 THIS DEED OF TRUST, made this day of . between MICHAEL J. WILDE and ALISANNE W. MAFFEI, husband and wife, herein called TRUSTOR, 3335 Somerset Way, Carson City, Nevada 89701 (city) (state) DOUGLAS COUNTY TITLE CO., INC., a Nevada corporation, herein called TRUSTEE, and GEORGE L. COFFEY and MARIE L. COFFEY, husband and wife, AS JOINT TENANTS , herein called BENEFICIARY, WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, that property DOUGLAS County, Nevada, described as: Lot 28 of FISH SPRING ESTATES, according to the map thereof, filed for record in the Office of the County Recorder of Douglas County, Nevada, on August 30, 1973, as Document No. 68451. AP#35-282-10. DUE ON SALE CLAUSE: If the trustor shall sell, convey or alienate said property or any part therof, or any interest therein, or shall be divested of his title or any interest therein in any manner or way, whether voluntarily or involuntarily without the written consent of the beneficiary being first had and obtained, beneficiary shall have the right, at its option, to declare any indebtedness or obligations secured hereby, irrespective of the maturity date specified in any note evidencing the same, immediately due and payable in full. Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits. For the purpose of securing (1) payment of the sum of \$ 28,834.06 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust. To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada on January 30, 1968, in the book and at the page thereof, or under the document or file number, noted below opposite the name of such county, namely: COUNTY воок DOC.
