allegations in said petition and account are true and correct;

that no creditor's claims have been filed; that after payment of

costs and expenses, this estate will be in a condition to be

finally settled and distributed to the heir named hereafter.

THEREFORE, IT IS ORDERED, ADJUDGED and DECREED

as follows:

1. That the First and Final Account of KATHLEEN J.

POLLART, also known as KATHLEEN J. MENGLER, as Executrix of

8 in accordance with the Last Will and Testament of said SAMUEL
9 J. STRIEBY, consisting of the following, which is hereby
10 set aside to her:
