The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner of the SKY HI #1 Claim;" the southwest corner is marked by a 4x4 Post 4 feet high, inscribed "SW Corner of the SKY HI #1 Claim;" the southeast corner is marked by a 4x4 Post 4 feet high, inscribed "SE Corner of the SKY HI #1 Claim;" the northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the SKY HI #1 Claim." There is also a 4x4 Post 4 at the center of each side line.

The monumentation and marking of the corners was completed by the 19 day of July, 1981.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
