We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 750 feet from the location monument in a Northerly direction, and 750 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner of the Sky Hi #2 Claim;" the southwest corner is marked by a 4x4 Post 4 feet high, inscribed "SW Corner of the Sky Hi #2 Claim;" the southeast corner is marked by a 4x4 Post 4 feet high, inscribed "SE Corner of the Sky Hi #2 Claim;" the northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the Sky Hi #2 Claim." There is also a 4x4 Post 4 at the center of each side line.

The monumentation and marking of the corners was completed by the 19 day of July, 1981
(must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
