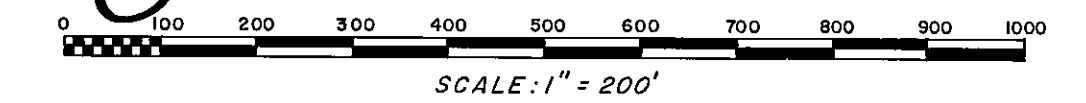

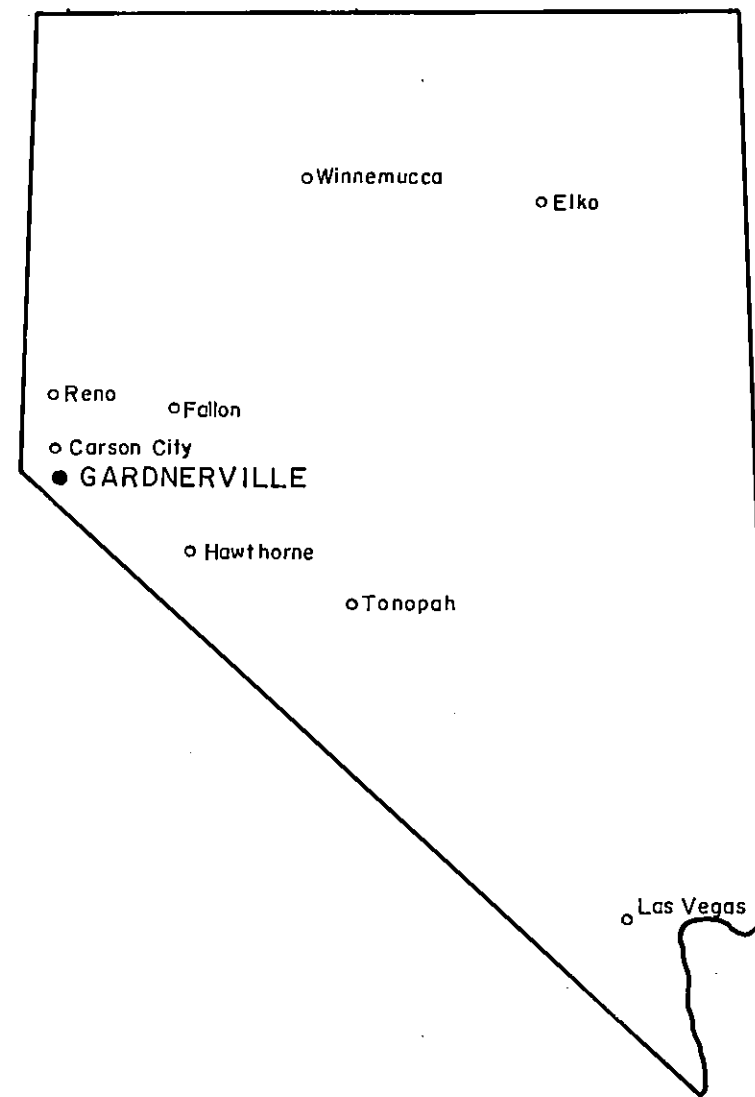
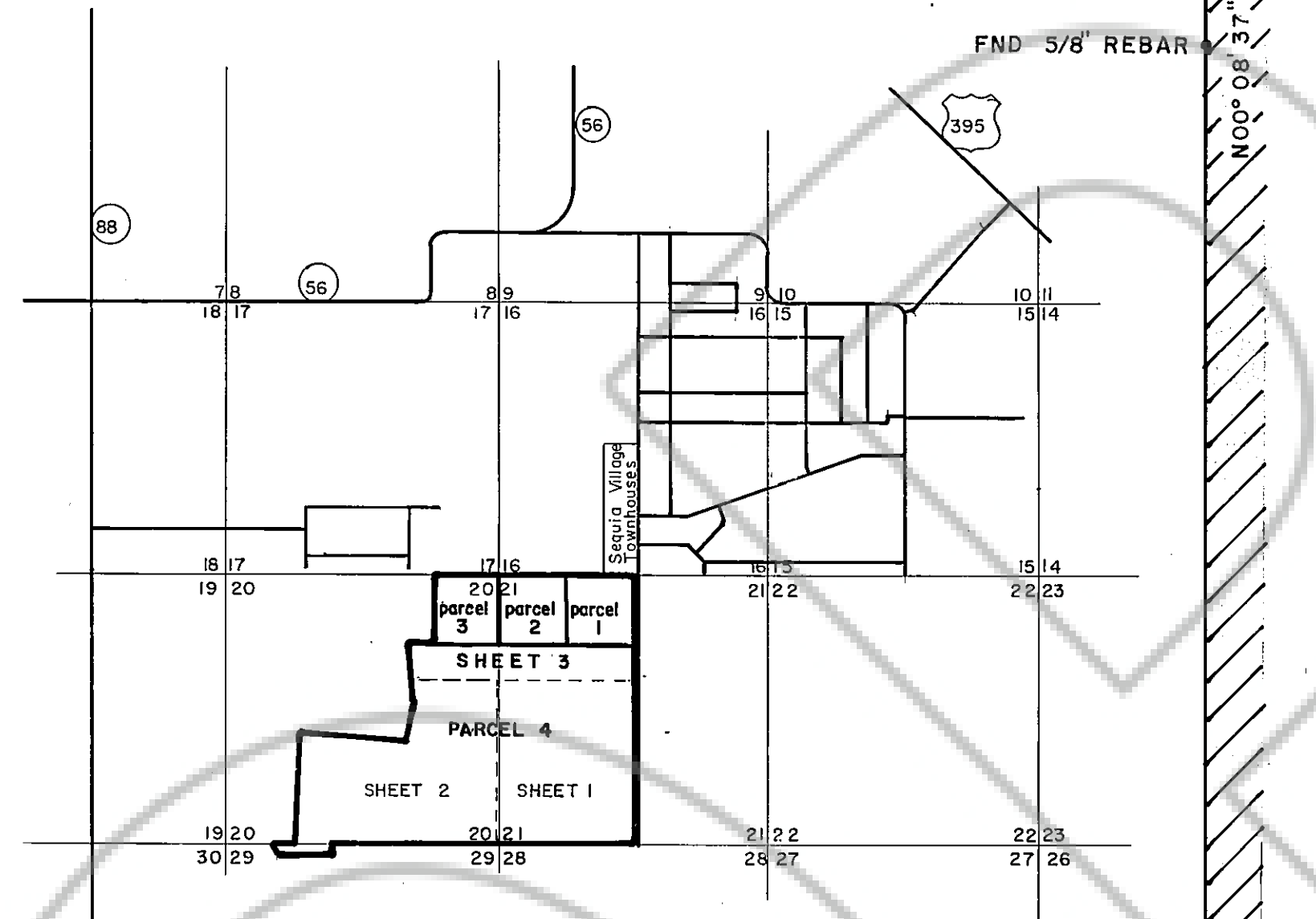

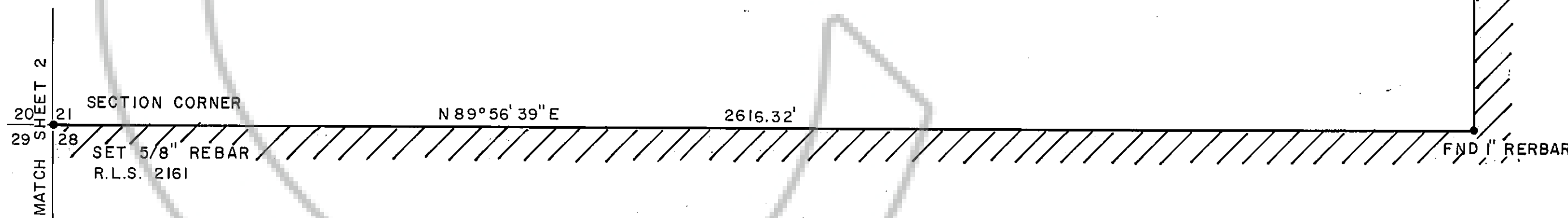
PARCEL 4



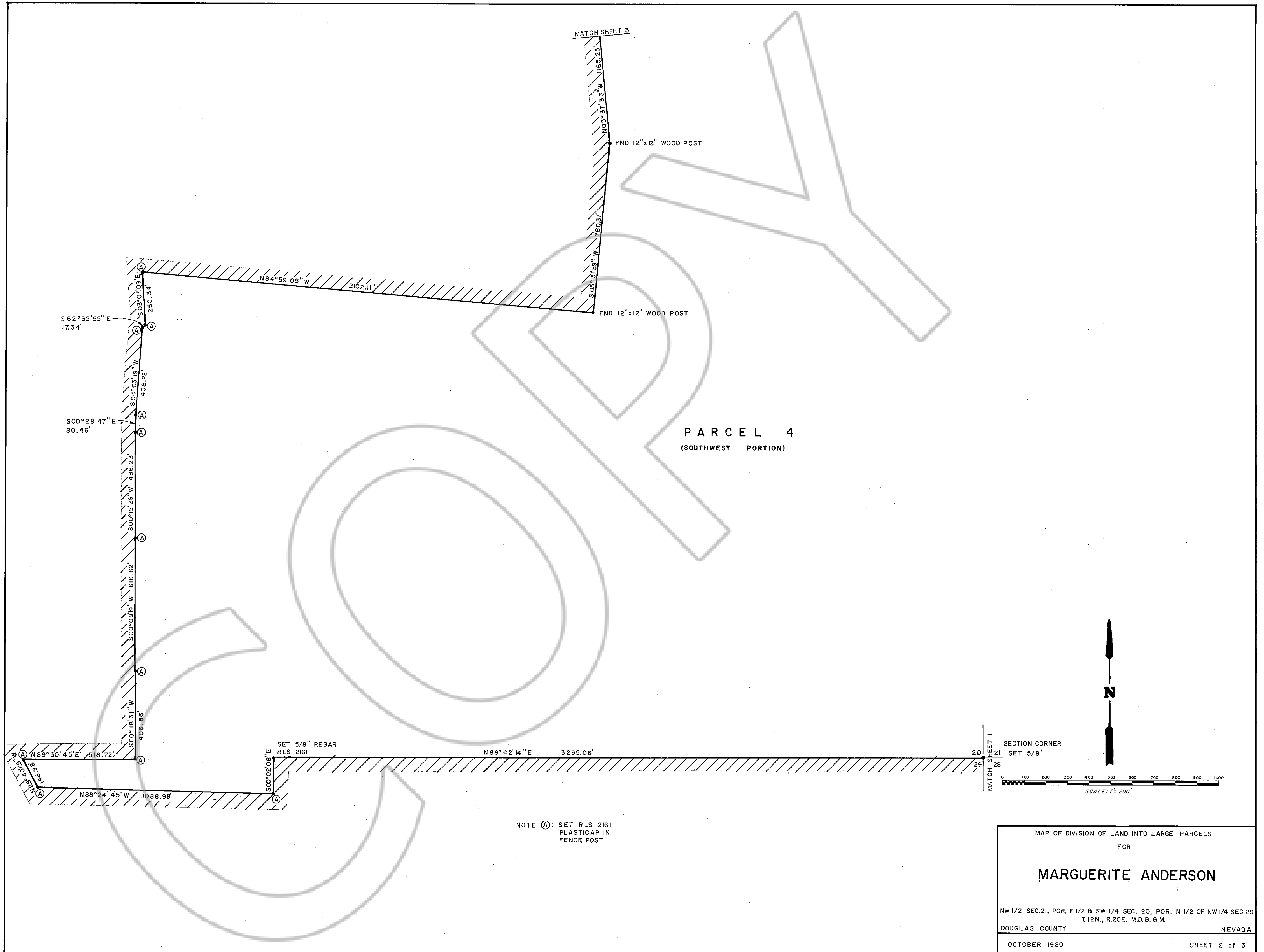
LOCATION MAP
