AMENDED JUDGMENT

16 It appearing to the Court that plaintiff, by and
17 through its attorneys, ROBISON, LYLE, BELAUSTEGUI & ROBB, and
18 defendant, by and through his attorney, CHARLES M. KILPATRICK,
19 have entered into and filed a Stipulation for Entry of Judgment
20 stating that plaintiff may have judgment entered in its favor
21 against defendant, and good cause appearing therefor;

22 IT IS ORDERED that judgment is herewith entered in
23 favor of plaintiff, CENVAL LEASING CORPORATION, a California
24 corporation, against defendant, TOM KERLEY, dba TOM KERLEY &
25 SONS CO., INC., for the principal sum of \$2,755.00, plus
26 attorney's fees and costs in the amount of \$806.10, for a total
27 Judgment of \$3,561.10.

28 IT IS FURTHER ORDERED that Judgment be paid by Judg-
29 ment Debtor as follows:

- 30 1. An initial payment of said principal sum in the
31 amount of \$1,000.00 shall be paid immediately.
32 2. Thereafter, monthly installments of ONE HUNDRED

1 FIFTY DOLLARS (\$150.00), the first installment to be due and
2 payable on the 5th day of December, 1981, continuing to be due
3 on the 5th day of each successive month thereafter until paid
4 in full.

5 3. Execution shall not issue upon the Judgment pro-
6 vided payments are made as herein ordered. An Execution shall
7 issue upon plaintiff's filing of an Affidavit with the Court
8 reciting that there has been a default in the payments and upon
9 mailing a copy of said Affidavit to Judgment Debtor at his
10 -address listed below, giving notice that five (5) days follow-
11 ing the filing of the Affidavit, an Execution will be requested
12 from the Clerk. If no counter affidavit is filed with the
13 Clerk within that five (5) day period indicating payment in full,
14 the Clerk shall issue the Execution for the principal sum of
15 \$2,755.00, plus attorney's fees and costs in the amount of
16 \$806.10, for a total of \$3,561.10, the amount of Judgment as
17 stipulated; together with interest at the rate of eight percent
18 (8%) per annum from October 10, 1980, less any payments made to
19 the date of default.
