AMENDED STIPULATED JUDGMENT  
AND ORDER UNIFORM RECIPROCAL  
ENFORCEMENT OF SUPPORT  
LAW

IT IS HEREBY STIPULATED by and between Plaintiff above-  
named, represented by MICHAEL J. ROESER, Deputy District Attorney  
for Douglas County, Nevada, and Defendant, NEIL RICHARD HOLVERSON,  
(who elects not to be represented by an attorney, it having been  
explained and he understanding his right to be represented by  
counsel of his choice) as follows:

That the Defendant hereby admits and does not deny  
that he is the father of the said minor children: JENNIFER  
HOLVERSON, born October 11, 1968, and LORI HOLVERSON, born  
March 9, 1970.

That the Defendant hereby acknowledges that he is now  
residing in Douglas County, Nevada, and that he is able to pay  
and will pay the sum of \$300.00 per month for the current support  
of his minor children, plus \$30.00 per month toward arrearages.  
Total payment shall be \$330.00 per month, commencing March 15,  
1982, and \$330.00 on the 15th day of each successive month there-  
after until further order of this Court.

That Defendant agrees that the arrearage which has  
accured to date is in the amount of \$10,800.00. Defendant agrees


1 that he will turn over as payment toward said arrearage \$3,500.00  
2 which had been previously posted as bail in a related criminal  
3 non-support case against Defendant. Said amount will be applied  
4 as support payment for the period of March, 1979 through  
5 January, 1980, plus \$200.00 accredited to February, 1980.

6 That Defendant agrees to pay the amount of \$1,500.00  
7 for the support period of February, 1980 through June, 1980,  
8 with \$200.00 accredited to July, 1980. Said \$1,500.00 shall  
9 have been paid by August 30, 1982.

10 FURTHER that said payments will be made in the form  
11 of a cashier's check, certified check or money order payable  
12 to the Clerk of the Court, Douglas County, and mailed to the  
13 District Attorney, Douglas County, Post Office Box 218, Minden,  
14 Nevada 89423. Said payment will then be forwarded to Sonoma  
15 County, Family Support Unit, Post Office Box 6534, Santa Rosa,  
16 California 95406.

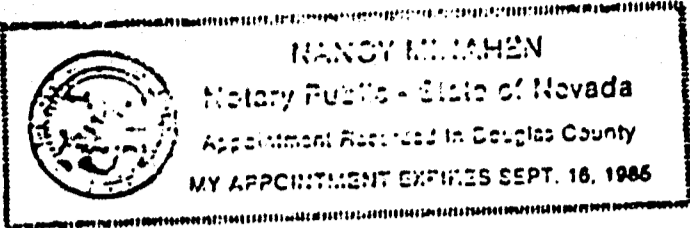
