IT IS HEREBY STIPULATED by and between Plaintiff abovenamed, represented by MICHAEL J. ROESER, Deputy District Attorney for Douglas County, Nevada, and Defendant, NEIL RICHARD HOLVERSON, (who elects not to be represented by an attorney, it having been explained and he understanding his right to be represented by counsel of his choice) as follows:

That the Defendant hereby admits and does not deny that he is the father of the said minor children: HOLVERSON, born October 11, 1968, and LORI HOLVERSON, born March 9, 1970.

That the Defendant hereby acknowledges that he is now residing in Douglas County, Nevada, and that he is able to pay and will pay the sum of \$300.00 per month for the current support of his minor children, plus \$30.00 per month toward arrearages. Total payment shall be \$330.00 per month, commencing March 15, 1982, and \$330.00 on the 15th day of each successive month thereafter until further order of this Court.
