ORDER ADMITTING DEFENDANT TO BAIL AND
ACCEPTING BAIL BOND SECURED BY PROPERTY OF SURETY

A criminal complaint having been filed in the above-entitled matter charging the above-named Defendant, SCOTT HARRISON MILLARD, with committing Murder, said act having been alleged to have been committed on or before the 24th day of March, 1982, and said amended criminal complaint having been filed March 30, 1982, and it appearing that the sum of \$90,000 (ninety thousand dollars), is such as will insure the presence of the Defendant, SCOTT HARRISON MILLARD, and it appearing that HARVEY H. MILLARD and LENA LOUISE MILLARD are the parents of SCOTT HARRISON MILLARD and that they have filed in these proceedings a bond wherein HARVEY H. MILLARD and LENA LOUISE MILLARD are surety, pledging real property having an approximate net asset value of \$117,000.00 (one hundred seventeen thousand dollars) to insure the presence of the Defendant at all times and places and required by law for his appearance in the above-entitled proceedings, and insuring that the Defendant shall at all times render himself amenable to the orders and process of the court in the requirements of the law, and if convicted shall appear for judgment and render himself in execution thereof, or in default thereof, pay to the People of the State of Nevada, the sum of

1 \$90,000 and (ninety thousand dollars) by Defendant, SCOTT HARRISON
2 MILLARD, and good cause appearing,

3 IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

4 1. That the above-named Defendant, SCOTT HARRISON
5 MILLARD, be, and hereby is, admitted to bail in the sum of
6 \$90,000.00 (ninety thousand dollars).

7 2. That the bail bond with the pledge by the parents of
8 SCOTT HARRISON MILLARD as surety, to wit: HARVEY H. MILLARD and
9 LENA LOUISE MILLARD, filed herein be, and it hereby is accepted
10 and approved.

11 3. That a certified copy of this Order be filed with
12 the Recorder of Carson City, State of Nevada, this day.


