IT IS HEREBY ORDERED as follows:

- 1. That plaintiffs shall discontinue use of the access roadway extending from the North boundary of Nixon Street in Genoa and crossing Lots 17 and 18, Block 2, Genoa Townsite and terminating at Lot 16, Block 2, Genoa Townsite which is owned by plaintiffs; said road being that which was the subject matter of the plaintiffs claimed easement.
- 2. That plaintiffs shall cause to be removed, the corral or "dog run" which extends to the West from said Lot 16 onto portions of Lots 6 and 7, Block 2, Genoa Township.

does not traverse upon said Lot 15 by moving the road to the East so that it is within "Genoa Street" as it appears on the Trustees Map of the Genoa Townsite, according to the Trustees Map of the Town of Genoa, filed in the office of the County Recorder of Douglas County, Nevada, dated September 1874. Until such time that the Defendants alter the course of said road, Plaintiffs shall be allowed to use that portion of said road which traverses Should the Defendants alter the course of said road so that it does not traverse on Lot 15, Plaintiffs right to traverse Lot 15 shall cease.
