Lot 516, Parcel A, Summit Village, Assessor's Parcel No. 11-262-14.

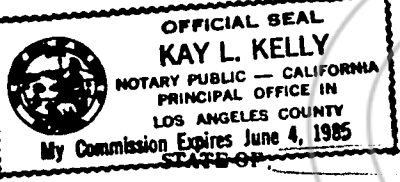
