

POWER OF ATTORNEY

1 KNOW ALL MEN BY THESE PRESENTS, that I, Joseph Conforte
 2 of the County of Washoe, State of Nevada, do hereby appoint
 3 Stanley H. Brown, of the County of Washoe, State
 4 of Nevada, my attorney, for me and in my name to ask, demand, sue
 5 for, collect, recover and receive all sums of money, debts, dues, accounts,
 6 legacies, bequests, interests, dividends, annuities and demands whatsoever
 7 as are now or shall hereafter become due, owing, payable or belonging to
 8 me, and have, use and take all lawful ways and means in my name or
 9 otherwise for the recovery thereof, by attachments, arrests, distress or
 10 otherwise, and to compromise and agree for the same, and acquittances or
 11 other sufficient discharges for the same, for me, and in my name to make,
 12 seal and deliver; to bargain, contract, agree for, buy, sell, mortgage,
 13 hypothecate, and in any and every way and manner deal in and with goods
 14 and merchandise, choses in action, and other property, in possession or in

 21 hereditaments, upon such terms and conditions, and under such covenants
 22 as he shall think fit and also for me and in my name and as my act and deed
 23 to sign, seal, execute and deliver and acknowledge such deeds, leases and
 24 assignment of leases, covenants, indentures, agreements, mortgages,
 25 hypothecations, bottomries, charter parties, bills of lading, bills, bonds,
 26 notes and other debts, and such other instruments in writing of whatever
 27 kind or nature as may be necessary or proper in the premises. Giving and
 28 granting unto Stanley H. Brown, said attorney and his
 29 substitute or substitutes, full power and authority to do and perform all and
 30 every act and thing whatsoever requisite and necessary to be done in and about
 31 the premises, as fully to all intents and purposes as I might or could do if per-
