the trust property to be sold to satisfy the obligations secured thereby.

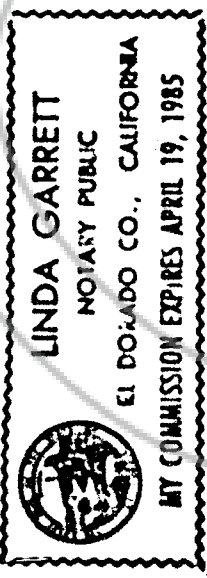
