QUIT CLAIM DEED

THIS INDENTURE is made this 8th day of July, 1982 by and between Arthur Ellis Hall and Joanne Ginn Hall, Trustees of the Hall Family Trust, created by Agreement dated February 1, 1980, and Arthur E. Hall, Trustee of the Valman Corporation Retirement Plan, created by Agreement dated November 22, 1978, (Grantors) and Valman Corporation, a Nevada corporation, and Douglas County, a political subdivision of the State of Nevada, (Grantees).

WHEREAS, Grantors are the owners of permits to appropriate underground water numbered 35574 and 39157 and the well which is constructed under authority granted in those permits, and

WHEREAS, Grantors desire to transfer their interests in the well and related water rights to Grantees; and

WHEREAS, Grantors desire to include Douglas County, Nevada, as a Grantee of said water rights, pursuant to the "Airport Water System Joint Participation Agreement" dated June 3, 1982, between Valman Corporation and Douglas County;

NOW, THEREFOR, Grantors in consideration of the sum of \$1.00 lawful money of the United States of America, to it in hand paid by the Grantee, the receipt whereof is hereby acknowledged, hereby transfer to Grantees all of Grantors' rights, title and interest in and to the well and water rights.

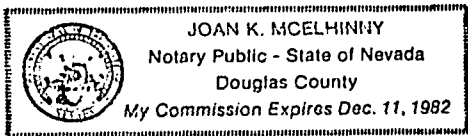

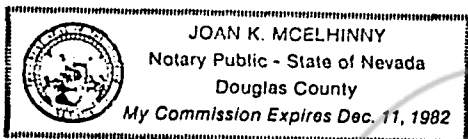
