Book 480 of Official Records, at page 885 Document No. 43686 has been fully paid


NOW, THEREFORE, NEVADA FIRST INVESTMENT CORP. Trustee,

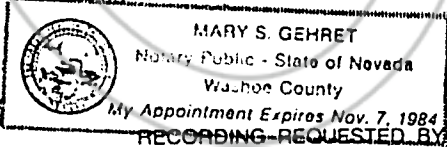


