30 is destroyed.



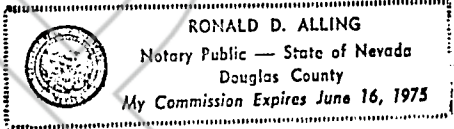

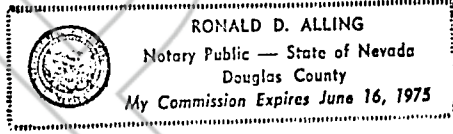
