184.92 feet to the POINT OF BEGINNING.

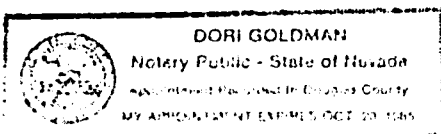

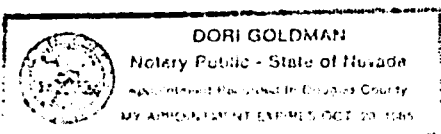
