29 suit in the sum of TWO HUNDRED SEVENTEEN AND 00/100 DOLLARS (\$217.00
30 for a total judgment of TWENTY-FOUR THOUSAND SEVENTY-ONE AND 24/100
31 DOLLARS (\$24,071.24) plus judgment interest at the rate of twelve
32 percent (12%) per annum thereon from the date hereof.
