

STANDARD DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 26 day of Dec, 1982, by and between

Merrill E. Schmidt (hereinafter referred to as "Trustor"),

and LVS Properties, Inc., a Nevada Corporation whose address is P.O. Box 5396, Stateline, Nevada 89449
(hereinafter referred to as "Trustee, and Tahoe Bronze, Inc. (hereinafter referred to as "Beneficiary")):

WITNESSETH:

That Trustor grants to Trustee in trust, with power of sale, that property located in the County of Douglas and State of Nevada described as follows, to wit:

Together with the rents, issues and profits thereof, subject, however to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits

For the purpose of securing (1) payment of the sum of \$ 17,200.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof, and (2) the performance of each agreement of Trustor incorporated herein by reference or contained on the reverse hereof; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidence by a promissory note or notes reciting that they are secured by this Deed of Trust; and (4) payment of assessments for maintenance, taxes and other purposes as assessed by the Kingsbury of Tahoe Timeshare Association.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of the Douglas County Recorder in the State of Nevada on November 5, 1982, in Book 1182 of record Page 259, Document Number 72898, shall inure to and bind the parties hereto, with respect to the property above described. Said agreements, terms and provisions contained in said subdivision A & B (printed on the reverse hereof) are by the within reference thereto, incorporated herein and made a part of this Deed of Trust for all purposes as fully as if set forth herein, and Beneficiary may charge for a statement regarding the obligation secured hereby, provided the charge therefor does not exceed a reasonable amount.

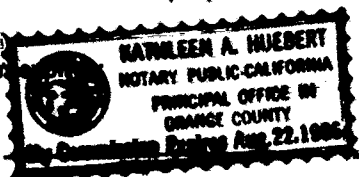
