14 Be it remembered this matter came on regularly for hearing,
15 plaintiff appearing through its attorney, RONALD D. ALLING, ESQ.,
16 of the law offices of MANOUKIAN, SCARPELLO & ALLING, LTD., and
17 defendant DEAN GARDNER not appearing but being in default, the
18 Clerk having entered his default herein on January 7, 1983.

19 The Court finds that plaintiff's complaint is verified and is for
20 a sum certain of \$3,469.79. The Court therefore treats all
21 of the allegations of plaintiff's complaint as true.

22 As conclusions of law, the Court finds that plaintiff is
23 entitled to have judgment against defendant according to the
24 prayer of its complaint. Because plaintiff's recovery will be
25 less than \$10,000.00, the Court further finds that plaintiff is
26 entitled to a reasonable attorney's fee and costs of suit as
27 part of its judgment.

28 NOW THEREFORE, it is hereby Ordered, adjudged and decreed
29 that plaintiff shall have judgment against defendant DEAN GARDNER
30 for the sum of \$4,946.06, the same being composed of \$3,469.79
31 principal together with interest from June 1, 1982, to the date
32 of judgment at the rate of 18% per annum in the sum of \$395.27,
