

1 NOTICE OF CLAIM OF LIEN

3 NOTICE IS HEREBY GIVEN that PACIFIC ENGINEERS OF NEVADA,
4 INC., a Nevada corporation, P. O. Box 20279, Reno, Nevada, 89515,
5 claims a lien upon the premises hereinafter described pursuant to
6 Chapter 108 of the Nevada Revised Statutes, for furnishing all
7 necessary labor and materials for installation of underground
8 utilities on said property, and in accordance with Nevada Revised
9 Statute 108.226 does hereby state:

10 (a) The amount of its demand, after deducting all just
11 credits and offsets is NINETY-SEVEN THOUSAND NINE HUNDRED SIXTY-
12 EIGHT DOLLARS AND EIGHTY-ONE CENTS (\$97,968.81), plus costs of
13 asserting this lien and the attorney's fees incident thereto.

14 (b) The name of the owner or reputed owner of the
15 improvements and real property against which a mechanic's lien
16 is claimed is HARICH TAHOE DEVELOPMENTS.

17 (c) Claimant was employed by RAINBOW, INC., the
18 general contractor on the project, and furnished all services
19 and materials in question at the request of RAINBOW, INC.

20 (d) The terms of the contract between the claimant
21 and RAINBOW, INC. were cash upon completion, and the contract
22 was completed on January 15, 1983.

23 (e) The property to be charged with the lien is
24 described as:

25 The Ridge, Tahoe Village Unit No. 3, at the
26 top of Kingsbury Grade near Heavenly Valley
27 Nevada side, Stateline, Douglas County,
Nevada.

28 WHEREFORE, PACIFIC ENGINEERS OF NEVADA, INC. claims a
29 lien upon the above-described property in the sum of NINETY-
30 SEVEN THOUSAND NINE HUNDRED SIXTY-EIGHT DOLLARS AND EIGHTY-ONE
31 CENTS (\$97,968.81), plus costs incurred in the preparation,
32 recording and asserting of this lien.

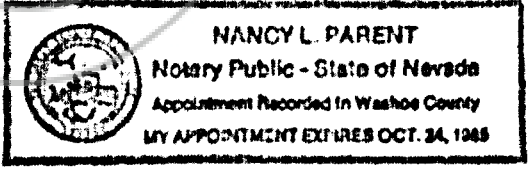
