

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this seventh day of March, 1983, between DANNY EARL JONES and ELEANOR FAYE JONES, husband and wife as joint tenants, herein called TRUSTOR, whose address is 2547 Henning Lane, Minden, Nevada 89423 (number and address) (city) (state) (zip) and

SIERRA LAND TITLE CORPORATION, a Nevada corporation, herein called TRUSTEE, and JOHN R. BAKER and BERNARDINA BAKER, co-trustees of the John R. Baker Trust dated December 29, 1981, herein called BENEFICIARY,

WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, that property in Douglas County, Nevada, described as:

The South 144.86 feet of the West half of the Southeast Quarter of the Northwest Quarter of the Northwest Quarter of Section 2, Township 13 North, Range 20 East, M.D.B. & M.

EXCEPTING THEREFROM the Easterly 30 feet.

ALSO DESCRIBED AS being Parcel 4 of the Parcel Map recorded for DONALD L. GARRISON, et ux, on April 4, 1979 in Book 479, of Official Records at page 179, Douglas County, Nevada, as Document No. 31252.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the sum of \$17,284.98** with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada on January 30, 1968, in the book and at the page thereof, or under the document or file number, noted below opposite the name of such county, namely:

The undersigned Trustor requests that a copy of any notice of default and any notice of sale hereunder be mailed to him at his address hereinbefore set forth.

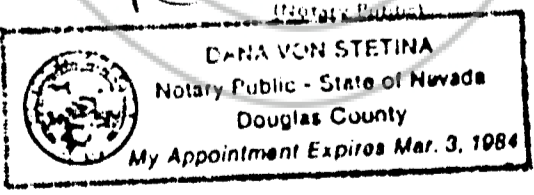
