MEMORANDUM OF AGREEMENT

This Memorandum of Agreement, made this 11th day of March, 1983, by and between ROY J. ATKINS and ELEANOR S. ATKINS, husband and wife, hereinafter referred to as "Seller", and THOMAS O. 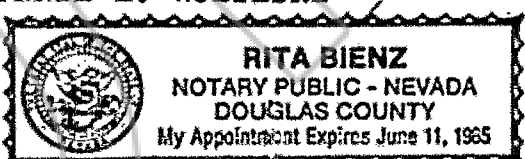
