

Assignment of Deed of Trust

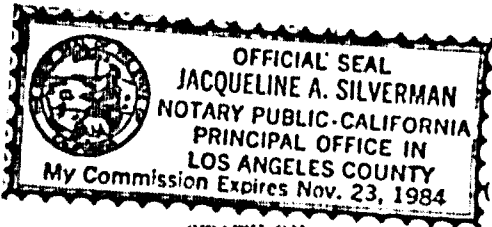
FOR VALUE RECEIVED, the undersigned hereby grants, assigns and transfers to Lila Anne Hill, an unmarried woman
