6 1983 to remit to Plaintiff the entire balance of said obligation,  
7 together with all interest accrued.

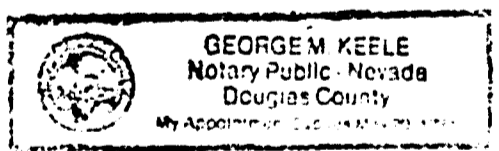
